I-20 INSTRUCTIONS

INSTRUCTIONS:

1. Fill out the I-20 application and send it back to Cirrus Aviation via e-mail, fax, or post.
2. Email a valid, current copy of Passport
3. Scan and email a piece of mail with home mailing address on it
4. Send Financial Verification to Cirrus Aviation along with the I-20 application.

*Financial verification of sufficient funds to cover training and living expenses is required. Verification may be in the form of a notarized copy of a bank statement, an approved loan application, or a notarized affidavit of support. All documents must be accompanied by a notarized English translation with currency converted into American dollars. (Example documents are included in this packet)

To calculate the amount necessary, an estimated cost of training programs desired plus estimated living expenses based on desired housing method.

EXAMPLE:

PPL, IFR, CPL, MEL (Private through Multi-Engine)	=	\$45,000
Living Expenses	=	<u>\$15,000</u>
TOTAL	=	\$60,000

5. Pay International Student Processing Fee to Cirrus Aviation. This is a nonrefundable \$400 fee that can be paid by credit card or bank wire transfer. Returning students that need a new I-20 are charged \$200.

Credit Card Payment Instructions:

- c) Click on **Scheduling Login - Click Here** In the upper right-hand corner
- d) Type your username and password and click **Login**

- e) Go to the **Records** tab at the top of the page and click on **Make Payment**
- f) You should be able to follow the instructions from there easily. You can enter your credit card information and the correct amount
